DelDot work on Oak Lane: severe draining issues at the intersection of Oak and Maple. Since there is no drainage system in Sandy Brae because when the community was planned, DelDot did not put them in, and over the years with increase in heavy vehicles and trucks, we have drainage issues. DelDot will communicate when surveying is complete.

Delmarva Power and Comcast Cable were called to investigate down lines behind two home on Spruce.

Constable was called to visit two homes for overgrown backyards. This was done after letters of concern were sent with no results. HOA fines have been initiated.

Discussion began on the condition of the entrance signs and the possible process that needs to be started about getting new ones. Nothing will be decided on or approved until the community is notified/participates.03.
