

### **UPKEEP & MAINTENANCE OF HOMES**

The aesthetic appearance of all homes affects the property value of all other homes; please make sure that you:

- Maintain your lawn & keep all your landscaping within the Covenant standards
- Keep your open spaces such as decks, porches, patios, front & sides of your house, free of clutter
- Replace torn screens
- Repair and/or paint any ancillary buildings such as sheds & garages
- Paint the exterior of your home as needed
- Power wash your home every 2 years
- Replace rotted exterior wood surfaces
- Perform necessary roof repairs
- All homes are obligated to have window treatments; no towels, sheets, cardboard, newspapers or painted windows are permitted

Just a reminder, Sussex County Code says political/election signs can go up 90 days prior to an election and can stay up 30 days after.

# **SANDY BRAE COVENANTS**

It is every resident's responsibility to know and abide by the HOA rules and restrictions which are intended to make every owner's and renter's life in our community safe, peaceful, and predictable. Abiding by the HOA Covenants establishes a standard within the community, helps keep our community attractive, and keeps property values up. Don't have a copy of your HOA Covenants? They are available 25/7 on our website, sandybraehoa.com in the Documents tab. Want a hard-bound copy, reach out to the Board and we can drop one off or mail one.

# **HOA ANNUAL DUES**

Per the Covenants, SBHOA annual dues are due into the HOA by January 1. There is a grace period of 30 days, but after that, <u>your dues are considered late</u>. Being late means there are fines plus a processing fee in addition to your dues. Get your dues into the HOA as soon as you get the bill in late November and avoid the fines.

### AR FORM and WHEN ARE THEY NEEDED?

Check out the 2020 Architectural Review form on the HOA website in the Documents tab. If you are planning any improvements whatsoever on the outside of your home or using a dumpster while having work done on the inside of your home or putting up a fence or doing inside work where trucks and large vans block the road or getting a shed, and many more things ....make sure you submit the AR form in a timely manner to the HOA Board. Too many residents are not properly using or submitting the AR Form and unfortunately ill will and fines have occurred. We do not have a lot of restrictions in our community, but the ones we have need to be upheld.

# **SPEED LIMIT & SAFETY**

The speed limit within the community is 25 MPH; please observe and obey it. Please be mindful of the many people, including small children, traveling on foot, by bicycle, and walking their dogs.

# **VEHICLES & PARKING**

No vehicles, except as may be reasonably classified as passenger cars, vans or pick-up trucks of one ton or less shall be regularly parked upon any lot where they may be seen from the street on a long-term and/or permanent basis. Vehicles must be kept on a paved driveway or within an enclosed garage, not on any property forward or to the sides of the front property line. Parking on grass adjacent to driveways or any other open space on your property is strictly prohibited. Non-compliance will lead to fines and towing. The operation of go-carts, un-muffled motor bikes and/or loud-engine recreational vehicles and all unlicensed vehicles are prohibited in all areas of the community including open lots. Trucks with over (2) axles, tractors, commercial and recreational vehicles and trailers are also prohibited.

#### **BOATS & TRAILERS**

All boats, boat trailers, horse trailers and other recreational trailers must be stored behind the property's front building line. No heavy-duty construction vehicles are allowed on the property or on the driveway.

# **MORE HOT TOPICS!**

#### **PARKING**

Due to our community insurance, "no parking "signs have been posted for years at the end of certain streets in the community that are designated common areas. Please do not park on that area or in front of it with any kind of vehicle. It puts the HOA in a liability situation we do not want.

### **SPRING CLEAN-UP / BACKYARDS**

Spring is just around the corner and a perfect time to clean out yard waste and junk that has accumulated in your backyard over the winter. During our March community drive around, we noticed many many yards in need of attention. Unfortunately, our community does not have yard waste removal. We have tried to find a solution for this, but we haven't been successful. The HOA cannot absorb the costs and not every resident wants this service. We will keep working on it.

### **PETS**

There are State and Local leash and animal waste laws that all pet owners must adhere to. In addition, pets should not be left unattended in/on any outside area (decks, porches, garages, balconies, etc.) or inside (open

doors and windows) where and when they can cause a noise nuisance to other residents and the community. And be a good neighbor.... pick up after your dog wherever you walk the animal; just because a lot is vacant, or tree lined does not mean you don't pick up dog waste. If you see anyone not picking up after their dog, on your property, immediately go up to them and ask them to pick up after their animal. Do not be confrontational. This situation has now reached a critical health issue in our community and if habits aren't changed, the Board will need to invest more money fighting it. Be part of the solution.... carry bags for dog waste be a responsible dog owner!



The Board has been informed of incidents of dog behavior in the community resulting in injuries to the dog their owner. The Board is urging all dog owners to make sure your dog is on a proper leash for their size and you, the owner, practice responsible neighborly behavior while walking your dog. If your dogs are in the backyard, please make sure every precaution is taken so they cannot escape and get injured, lost, etc.

We urge all owners, when walking your pet, to abide by Delaware Leash Law. And, if your pet is not dog, child, or adult friendly, to advise those that might be around you or walking toward you. Every resident, and dog, deserves a safe and happy walk around the community.

Pets are certainly welcome in Sandy Brae and are an important part of life in our community. The Board just wants everyone to be safe.

# **HOT TOPICS CONTINUES!**

#### **BE RESPECTFUL OF YOUR NEIGHBORS**

While everyone is fond of the spring and summer weather for planning and partaking in outdoor activities, please be aware and cognizant of your neighbors. Keep noise levels to a reasonable level. Also, please be mindful of not starting activities very early in the morning or continuing on into the early hours of the night. If you are having a gathering at your home and there will be a lot of cars, remember to tell your neghbors and park cars half on the grass half on the street so the street is passable. Everyone is entitled to the personal "quiet" enjoyment of their home and the community. And per the covenants, no firecrackers or fireworks are permitted in the community.

# Do I need a permit from DelDot if I am doing work on my driveway?

The streets in Sandy Brae are owned and maintained by the State of Delaware; the HOA does not own the streets. So, if you are putting in a new driveway, replacing an existing driveway, adding onto an existing driveway, you must apply to DelDot for an entrance permit. Step #1 is to contact Bill Kirsch, DelDot Southern Division Entrance Supervisor at <a href="www.william.kirsch@state.de.,gov">william.kirsch@state.de.,gov</a> for more information. Step #2, you need to fill out an HOA Architectural Review Form. If the Board does not see a permit from DelDot, we cannot approve your driveway.

Websites, such as Coupons.com, is a savings-black hole with coupons ideal for your grocery runs, notes Huffstetler. You just have to select the ones that match your list or your preferred brands and print. The Balance writer Eric Rosenberg is a fan of CouponSherpa.com, which has been in the printable coupon game for quite some time. It offers deals from a range of retailers such as Amazon, Gap, Target and Old Navy.

Look at the packaging of products you already own to see if it includes a coupon, and review your receipts — sometimes a coupon for your next shopping trip is printed at the bottom or perhaps after completing a survey, you'll earn some savings.

# Target the competition

Even stores you don't shop at can be a source of savings at the retailers you do frequent. Your favorite store might honor competitor's coupons or match the discounted price, notes Huffstetler. And if your store doesn't currently double coupons or allow you to stack coupons — using multiple coupons on one item — it might be time to find a retailer that does so that you can start saving more.

"When you have coupons that exceed the value of the items you're buying, use them at Walmart. They'll allow you to apply your coupon overage to other items, or will even give it back to you in cash," according to Huffstetler.

# Find the right app

Whether you're shopping online or at a brick and mortar establishment, there's an app designed to help you save. You just have to match the best app to your shopping experience. If you're on grocery detail, check out the benefits the app lbotta® offers in terms of organization, cost-savings and cash back, suggests Rosenberg.

Coupons are a great way to save, but you do have to do some work to make them work for your shopping lifestyle. Do a bit of coupon research before you start adding things to your cart, both in-person and online, and over time every dollar will add up and help you save.

# April Fools' Day

Although April Fools' Day, also called All Fools' Day, has been celebrated for several centuries by different cultures, its exact origins remain a mystery. Some historians speculate that April Fools' Day dates back to 1582, when France switched from the Julian calendar to the <u>Gregorian calendar</u>, as called for by the Council of Trent in 1563.

People who were slow to get the news or failed to recognize that the start of the new year had moved to January 1 and continued to celebrate it during the last week of March through April 1 became the butt of jokes and hoaxes. These pranks included having paper fish placed on their backs and being referred to as "poisson d'avril" (April fish), said to symbolize a young, easily caught fish and a gullible person.

Historians have also linked April Fools' Day to festivals such as Hilaria, which was celebrated in <u>ancient Rome</u> at the end of March and involved people dressing up in disguises. There's also speculation that April Fools' Day was tied to the <u>vernal equinox</u>, or first day of spring in the Northern Hemisphere, when Mother Nature fooled people with changing, unpredictable weather.

April Fools' Day spread throughout Britain during the 18th century. In Scotland, the tradition became a two-day event, starting with "hunting the gowk," in which people were sent on phony errands (gowk is a word for cuckoo bird, a symbol for fool) and followed by Tailie Day, which involved pranks played on people's derrieres, such as pinning fake tails or "kick me" signs on them.

In modern times, people have gone to great lengths to create elaborate April Fools' Day hoaxes. Newspapers, radio and TV stations and Web sites have participated in the April 1 tradition of reporting outrageous fictional claims that have fooled their audiences.

In 1957, the BBC reported that Swiss farmers were experiencing a record spaghetti crop and showed footage of people harvesting noodles from trees; numerous viewers were fooled. In 1985, *Sports Illustrated* tricked many of its readers when it ran a made-up article about a rookie pitcher named Sidd Finch who could throw a fastball over 168 miles per hour. In 1996, Taco Bell, the fast-food restaurant chain, duped people when it announced it had agreed to purchase Philadelphia's Liberty Bell and intended to rename it the Taco Liberty Bell. In 1998, after Burger King advertised a "Left-Handed Whopper," scores of clueless customers requested the fake sandwich.

If there is a life after this one, I will be looking for this little girl who gave her daddies a lifetime of love. She is missed every moment of every day.
