Pete was very receptive and promised to help us all he could. The HOA Board would like to thank Betty Deacon for volunteering to make the contact with Pete and for her follow thru in arranging the meeting. We have contacted Pete's office to check on the progress and he has reached out to DelDot for an official estimate for all the work listed. DelDot presented to the HOA an estimated cost to do all the streets was \$88K. As of now, we have not heard from Senator Lopez.

This & That......

- Current HOA Board meeting agendas, minutes and financials are always posted on the website in the document tab.
- Any resident in good standing is invited to the monthly Board meeting.
- Who gets the quarterly HOA newsletter? EVERYONE! Director, John Luzzi sends it out in a link on Facebook and to your email. Then, Director, Lorie Seaman mails to the almost 70 residents/renters who do not have or won't give us their emails. Residents and renters get our quarterly newsletter. The newsletters are on the website as well.
- Every lot in Sandy Brae is owned and 8 of those lots are currently undeveloped. There are 259 lots and 253 owners in our community.
- Sandy Brae was developed in 1966. The HOA was incorporated in 2003.
- Our Annual Meeting must be held every June, according to the By-Laws, in the middle of the month, and somewhere in the Lewes zip code.
- Trash pick-up is arranged by the individual owners. We do not have a community contract with anyone.
- Yard waste removal is an issue in our community. Got a solution? Send us an email because we have been trying for 4 years and cannot find a workable solution.
- Sandy Brae HOA does have a Facebook page! Please join.
- Sandy Brae is the last residential community on Plantation Road on well water.
- Sandy Brae actually does not have any common areas. But we are obligated by the agreement with DelDot
 to keep the grass mowed on the perimeter of the community, at the end of 6 streets, the triangle at Old
 Postal, and the area around the pumping station in the third section.

2022 Dues Notice

At the September 2021 Board meeting, the Board voted to increase the 2022 dues by \$15 to \$125 annually. In addition to all the operational costs going up, we want to take that increase amount totaling \$3,885 and put it towards the potential road repair. Every little bit will help with that expense in the event we cannot get all of it underwritten. And, if we are lucky to get our road repair underwritten, then we plan to use that money for entrance signs solar lights and landscaping around the Postal-Plantation sign.

Why do we have an Architectural and Modification Form? When do I use it?

Our HOA has used an "AR Form" since being incorporated in 2003. Having an "AR Form" is part of the Board's fiduciary responsibility to do what is best for the aesthetic look of the community. It is the owner's responsibility to be familiar with this form and to <u>use it when doing anything on the exterior of the house or in the yard.</u>

Over the years, this form has been modified by Board policy to fit the ever-changing needs of the community and the times. And although the name has remained the same, our Covenants require it for new builds, major construction, any modifications, replacements, additions, or alteration of any kind on the outside of the home. You also need this form for sheds, dumpsters, and POD storage.


It is very impressive that the Board has processed 47 AR Forms from January-September of this year. We love seeing these forms come in because it means residents are improving their property, upgrading their property (inside or out) and that increases the value of their home and all our homes!

Update on the Covenant Committee

After reaching out to our community several times for volunteers for this committee, we have 4 residents and 2 Board members that have joined the committee. The first meeting was held on September 14 at 5:30pm in the Lewes Library. Director Lorie Seaman will co-chair the committee. Each Covenant will be reviewed for revision, deletion, or correction. A timeline to submit any of the above to the Board for approval was established, then it will be sent to the attorney for final review, then sent out to the community to vote. The majority of the community must vote yes on any covenant changes before they can be enacted. The goal is to have this document to the community for vote in January 2022 or before.

Reliable Service and Tree Maintenance

Falling or damages Trees and branches are the leading cause of unscheduled outages. Our tree maintenance program helps keep safe clearances between trees and power lines in our area, using licensed and certified arborists and contract tree experts.



Right Tree, Right Place

If you're planning to plant trees on your property, please consider nearby overhead utility lines as you decide on the type and location on each tree.

- *Tall Trees over 20 feet high*, such as maple, sycamore, oak, spruce, and pine should be planted at least 50 feet away from power lines.
- *Medium Trees 25 to 40 feet high*, such as birch, serviceberry, and honey locust, should be planted at least 20 feet away from power lines.
- Small Trees under 25 feet high, such as dogwood, flowering, cherry, and crabapple, are better for areas close to power lines.

Each species grows differently, so think ahead to when its fully grown. Please contact Miss Utility at 811 before digging.

Permitting Requirements

A County permit is required for certain building, placement, or improvements made to a property within Sussex County. Additional permits may be necessary for properties inside the boundaries of a municipality. If your building, improvement, or placement project is located inside of a town or city in Sussex County, please be sure to contact them for local requirements.

The following all require a permit from Sussex County:

Single and Multi-Family Dwellings

Commercial Construction

Accessory Structures

- Sheds Pre-built & Site Built.
- Gazebos & Pergolas
- Carports
- Playhouses
- Detached Structures (Garages & Pole Buildings)
- Agricultural Buildings
- Greenhouses
- Pools-Inground/Aboveground
- Solar Panel Installations (ground and structure mounted)
- Retaining Walls

Manufactured Homes

New or Replacement

Additions & Renovations Accessory Structures

- Additions
- · Wood Docks, Porches, Sunrooms
- Gas Fireplaces, Inserts, and Coal.
- Siding
- Roofing*
- Interior/Exterior Renovations
- · Finished Bonus Room
- · Finished Basements
- · Patios -- Concrete/Brick/Paver
- Fences
- * Roofing includes structural sheathing or change in material such as shingle to metal.

In Delaware, if you are at least 18 years old, you may make a written "Advance Health Care Directive" to accept or refuse most health care treatments or procedures. Your Advance Health Care Directive will tell your doctor what you want if you become unable to decide yourself.

WHAT IS AN ADVANCE HEALTH CARE DIRECTIVE?

Under Delaware law there are two types of Advance Health Care Directives:

Instruction for Health Care Decisions (Living Will)
 A Power of Attorney for Health Care


An Instruction for Health Care Decisions, previously referred to as a living will, is a written statement of your wishes about healthcare treatment. It includes your wishes for treatment when you are terminally ill, permanently unconscious, or suffer from serious illness or frailty.


A Power of Attorney for Health Care allows you to name another person as an agent to make healthcare decisions for you if your medical condition makes you unable to do so. You can appoint any adult over the age of 18 to be your agent. However, if you are a resident of a long-term care facility, the agent cannot be an employee of the facility unless he/she is related to you.


If you want to initiate an Advance Health Care Directive, you must do so while you are still capable and competent to make healthcare decisions. Two witnesses who are at least 18 years old must watch you sign the Advance Health Care Directive. You must choose witnesses who are not members of your family, will not inherit anything from you when you die, and do not have to pay for your care. If you are in a hospital, nursing home, or similar facility when you sign your written instruction, you must choose witnesses who are not employees of the facility. In addition, if you are in a nursing home or similar facility, one of the witnesses must be a Long-Term Care Ombudsman or the Public Guardian. If you do not have an Advance Health Care Directive and you are unable to make decisions, a member of your family will be asked to make healthcare choices for you.

10 "NEED TO KNOWS"


Anyone over the age of 18 with capacity can prepare a healthcare directive.









An Advanced Healthcare Directive is only used when you have lost capacity and can no longer make decisions for yourself.
